



#### IMPLEMENTATION OF THE RPMS-PPST IN THE SCHOOLS DIVISION OFFICES

To: Schools Division Superintendents

- The Department of Education, after its series of field consultation, has identified the implementation of the RPMS-PPST as one of the priority issues/ concerns in the Region.
- 2. This Office underscores anew the critical role of RPMS-PPST in human resource management particularly in terms of placement and promotion. In line with this, DepEd Regional Office I shall embark on a large-scale study on the implementation of RPMS-PPST which primarily aims to harmonize the implementation of the system in the Region.
- 3. The study shall be done in two phases. The first phase shall focus on the administration of the online survey questionnaire. The respondents for this phase shall be teachers and principals/ school heads of the identified schools (see attachment). The school heads of the selected schools are enjoined to randomly identify teacher-respondents according to the number indicated.
- 4. The identified respondents shall fill out the online survey questionnaire through the following links:

- 6. Phase Two shall be the conduct of the Focus Group Discussion (FGD). A team from the Regional Office shall facilitate the conduct of the FGD between February 20-28, 2020. Participants are school heads and teacher-respondents from among those who have accomplished the survey questionnaire. Attached is the list of schools involved in the FGD and the corresponding schedules and venues.
- 7. Expenses relative to the conduct of the activity such as transportation and per diem shall be charged against their MOOE/school/local funds subject to the usual accounting and auditing rules and regulations.
- 8. All requested information shall be used for the sole purpose of determining the implementation of RPMS-PPST in the Schools Division and in the Region. Relative concerns shall be treated with utmost confidentiality pursuant to RA 10173 otherwise known as Data Privacy Act of 2012.
