- As stipulated in DepEd Order No. 34, s. of 2022 otherwise known as School Calendar and Activities for School Year 2022-2023, the SPG and SSG elections shall be conducted on the first to second week of September. In this regard, the Department issues the revised Interim Guidelines on Student Government Elections through OASYASC Memorandum titled Youth Commission on Elections and Appointments (Youth COMEA) for School Year 2022-2023, which will serve as basis for the said elections.
- 2. In line with this, all public and private elementary and secondary schools shall fill out this Google Form (<a href="https://bit.ly/COMEAComposition">https://bit.ly/COMEAComposition</a>) on or before September 4, 2022. The information that will be provided in this Google Form will serve as our basis in monitoring the compliance of schools to the abovementioned guidelines.
- 3. In addition, all Youth COMEA shall submit one (1) hard copy of the official list of school's newly appointed officers duly signed and proclaimed by the Chief Commissioner (School Head) to the School Division Office of Alaminos City's Youth Formation Unit on or before September 23, 2022.
