- 1. Pursuant to Republic Act (RA) No. 9155 known as the Governance of Basis Act of 2001, the Department of Education issues the Implementing Guidelines on the Establishment of School Governance Council (SGC) as stipulated in DepEd Order No. 26, s. 2022. This policy aims to recognize and strengthen the role of stakeholders, alongside Local Government Units (LGUs), as partners in providing learners accessible and quality education, upholding children's right, and promoting respect and well-being in the learning environment to ensure effective education service delivery. The SGC shall function as a structure for shared governance and a feedback mechanism at the school level.
- 2. Relative to this, the SDO shall conduct initial roll-out on SGC Functionality Assessment Tool for public secondary schools. Likewise, the SDO shall validate and verify the data submitted by the SGCs. The SDO validating team shall be composed of:
