It further provides that all the country's artistic and historic wealth constitutes the nation's cultural treasure and shall be under the protection of the state, which may regulate its disposition.

Hence, CCP through its ARTS ONLINE program has curated a collection of learning resources. ARTS ONLINE is a video streaming platform for the "new normal" that continues to engage and connect artists to their audiences through art workshops, artists' talk, and lecture-demo of the different art forms. These are learning opportunities for children, for general audience, for artists and for learners and parents - making art matter to every Filipino.

In light of covid-19, ensuring that Filipinos will still benefit from educational assets of the arts, ARTS ONLINE aims to: (1) provide platform for the community of art learners and artist/teachers; (2) engage and broaden audiences for arts appreciation and learning; (3) create opportunities for artists to continue their work in arts education; and (4) provide learning materials for the arts curriculum.
