SUBJECT : **REITERATION OF HEALTH AND SAFETY PROTOCOLS IN THE LIGHT OF COVID-19 PANDEMIC**

DATE : November 10, 2022

1. This office reiterates the implementation of DepEd Order No. 39, s. 2022: Health and Safety Protocols in the light of the COVID-19 pandemic, dated September 19, 2022, and DepEd Order No. 48, s. 2022: Implementing Executive Order No. 07, s. 2022 and Amending DepEd Order No. 39, s. 2022, dated November 2, 2022.
2. Schools are enjoined to participate in the DOH *PinasLakas* campaign. Teaching and non-teaching personnel are encouraged to have at least three (3) doses of their COVID-19 vaccination (two [2] primary doses and at least one [1] booster dose). Reporting of updated number of vaccinees shall be accomplished monthly.
3. Please be reminded that although wearing masks in indoor and outdoor spaces has been declared voluntary, the School Health & Nutrition section still encourages wearing masks, considering the rising cases of COVID-19 and hand, foot and mouth disease.
4. As part of the preventive and control measures for COVID-19, seventy (70) pieces of rapid COVID-19 antigen test kits received from the Regional Office will be allocated to seven public schools. Teaching and non-teaching personnel may avail of the rapid antigen testing. The scheduled rapid screening is as follows:
