

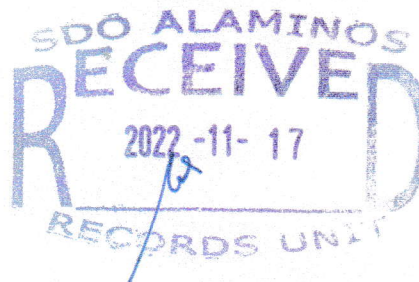

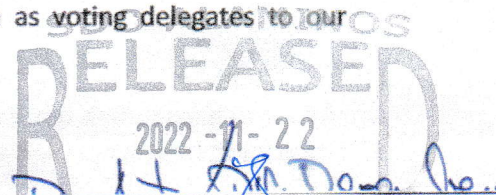
Dear Madam,
