

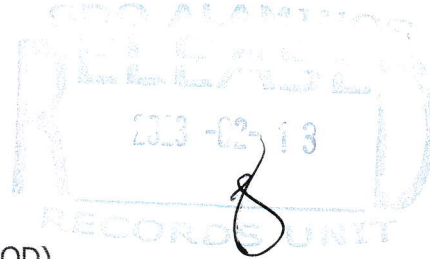



SUBJECT : **SUBMISSION OF FY 2022 GENDER AND DEVELOPMENT ACCOMPLISHMENT REPORT (GAD AR)**

1. Pursuant to the Philippine Commission on Women (PCW) Memorandum Circular No. 2022-07 of the Submission of FY 2022 GAD Accomplishment Report, all line departments, constitutional bodies, judicial and legislative bodies, attached agencies/ bureaus, other executive offices, and government-owned and/or controlled corporations shall submit the consolidated FY 2022 Gender and Development Accomplishment Report (GAD AR) through the PCW Gender Mainstreaming Monitoring System (GMMS). This is in accordance with Section 36 of Republic Act No. 9710 of the Magna Carta of Women which states that the utilization and outcome of the GAD budget shall be annually monitored and evaluated.
2. In this connection, the Schools Division Office (SDO) is requesting all public elementary and secondary schools to submit hard and soft copies of their GAD ARs on or before February 15, 2023. The soft copy of the GAD AR shall be submitted via the link: [bit.ly/3JXxbC2](https://bit.ly/3JXxbC2).
