

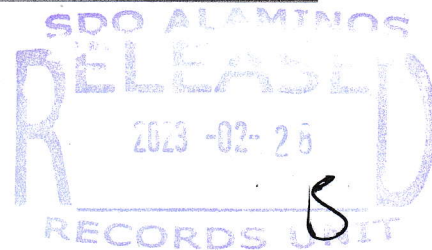

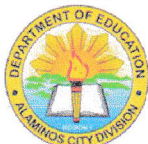

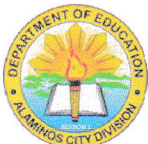
3. Coaches and athletes are instructed to submit themselves for the medical and dental screening on February 28, 2023 as reflected on the DM -2023-098.
