- 1. This office reiterates the implementation of DepEd MEMORANDUM No.008, s. 2023, or the "Multi-Year Guidelines on the Results-based Performance Management System (RPMS)-Philippine Professional Standards for Teachers (PPST)", to all concerned personnel in the Division.
- 2. DM No. 008, s. 2023 is consistent with DepEd ORDER No. 2, s. 2015 or the "Guidelines on the Establishment and Implementation of the Results-based Performance Management System (RPMS) in the Department of Education (DepEd)" and also in accordance to Section 5 of DepEd ORDER No. 42, s. 2017 or the "National Adoption and Implementation of the Philippine Professional Standards for Teachers (PPST)".
- 3. Furthermore, this Memorandum covers all teachers in the public elementary and secondary schools and all community learning centers, including teachers assigned to teach Alternative Learning System, Madrasah Education, Special Education and Special Science Education. Moreover, this issuance gives guidance to the raters, ratees, approving authorities and other personnel who are tasked to evaluate the teachers' performance that should be anchored on the PPST.
