- 1. The Schools Division Office of Alaminos City, through the Division Federation of Supreme Student Government (DFSSG) and the Youth Formation Unit, will be conducting a Coastal Cleanup on the shores of Brgy. Telbang on June 12, 2023. The assembly for the activity will take place at 6:00am in the Brgy. Telbang Auditorium.
- 2. The activity aims to:
 - Raise awareness about coastal ecosystem impact and conservation importance.
 - Engage youth in hands-on cleanup to remove debris and pollutants from coastlines.
 - Foster waste management, recycling, teamwork, and leadership skills among youth.
 - Encourage collaboration with local communities and stakeholders for long-term coastal conservation.
 - Empower youth to advocate for sustainable practices and influence policies to address coastal pollution.
- 3. All public schools, and private schools with representatives in the DFSSG, are requested to participate in this activity. The participants for this activity shall include the Division Youth Formation Coordinator, one (1) SSG Teacher-Adviser per school and four (4) SSG Officers per school. The SSG teacher-advisers shall serve as the chaperones and ensure the safety of the SSG officer-participants of the abovementioned activity.
- 4. All participants are required to:
 - a. bring their own trash bags/sacks;
 - b. bring their own snacks;
