- 1. To guide Grade 1 teachers, particularly the newly hired, in the execution of the Eight-Week Curriculum for Grade1, this Division will conduct a **Training-Workshop for Teachers on the Catch-up Plan for Grade 1** at the Empress Island Hotel on September 14-16, 2023.
- 2. The activity aims to hone the skills of teachers on the proper conduct of the daily competencies per week of the Eight-Week Curriculum, localize the activities that are developmentally appropriate for the Grade 1 learners, and design an Action Plan as their guide for the eight-week implementation.
- 3. The first day of the activity (September 14, 2023) is a pre-workshop. It is a school-based activity wherein teachers in Grade 1 will conduct the Comprehensive Rapid Literacy Assessment and Numeracy Assessment in their respective classes. The results will be discussed on the second day (September 15, 2023) at the Empress Island Hotel.
- 4. This is a live-in training workshop. Workshop 2 will be after dinner on September 15, 2023. The last day of the activity will be in the afternoon of September 16, 2023.
- 5. School Heads are advised to send one (1) teacher in Grade 1 to attend the said activity.
