- 1. Republic Act 9729 or the Climate Change Act of 2009 has been amended by R.A. 10174, which defines the power and functions of the Climate Change Commission (CCC) in recommending legislation, policies, strategies, programs on and appropriations for climate change adaptation and mitigation, and formulating strategies on mitigating Green House Gas (GHG) and other anthropogenic causes of climate change.
- 2. As stated in the said issuance, a GHG inventory is an estimate of all emissions and removals of GHG from given sources and sinks within a defined spatial and temporal dimension.
- 3. In view of this, the Local Government Unit of Alaminos City through the City Disaster Risk Reduction and Management Office, facilitated a workshop to enhance the Local Climate Change Action Plan to incorporate the greenhouse gas (GHG) inventory aligned with the Comprehensive Development Plan of the city.
- 4. The Disaster Risk Reduction and Management unit of this division will be monitoring the monthly odometer reading, fuel and cost consumption of all service vehicles assigned in offices and schools, either acquired thru procurement or donation. Monitoring forms will be given to concerned personnel for the necessary details and data needed.
